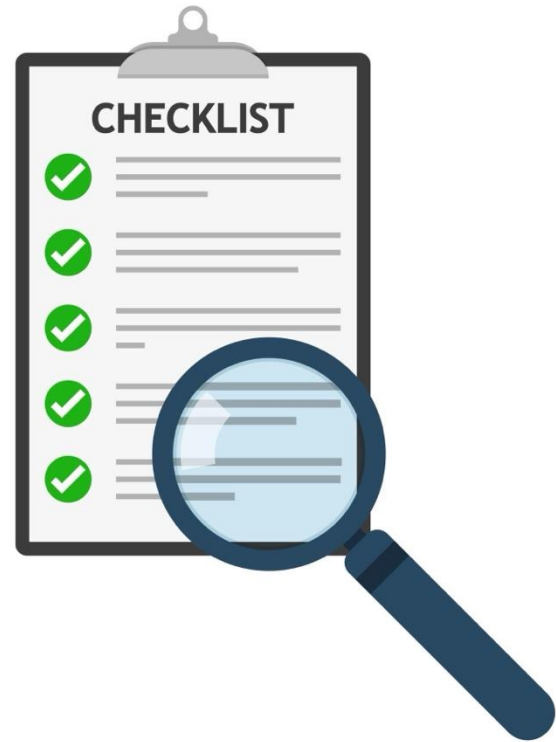
December Connection

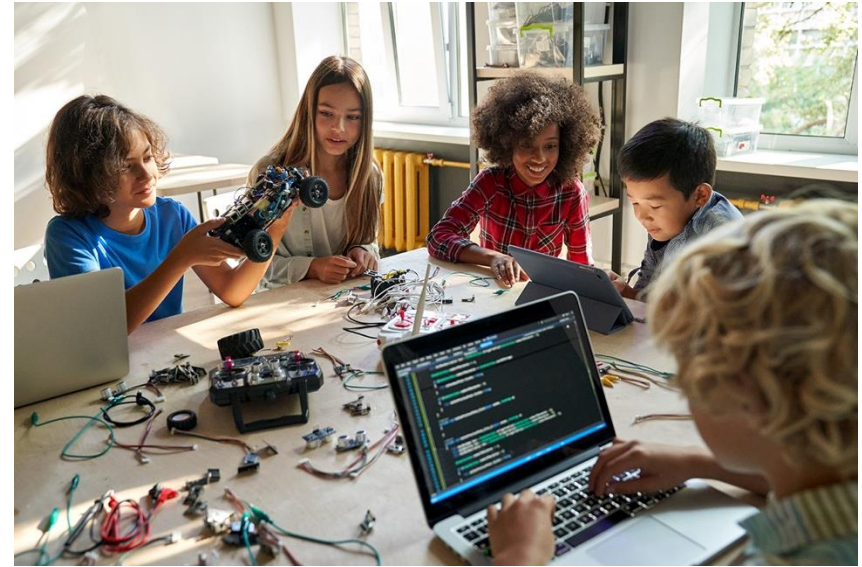

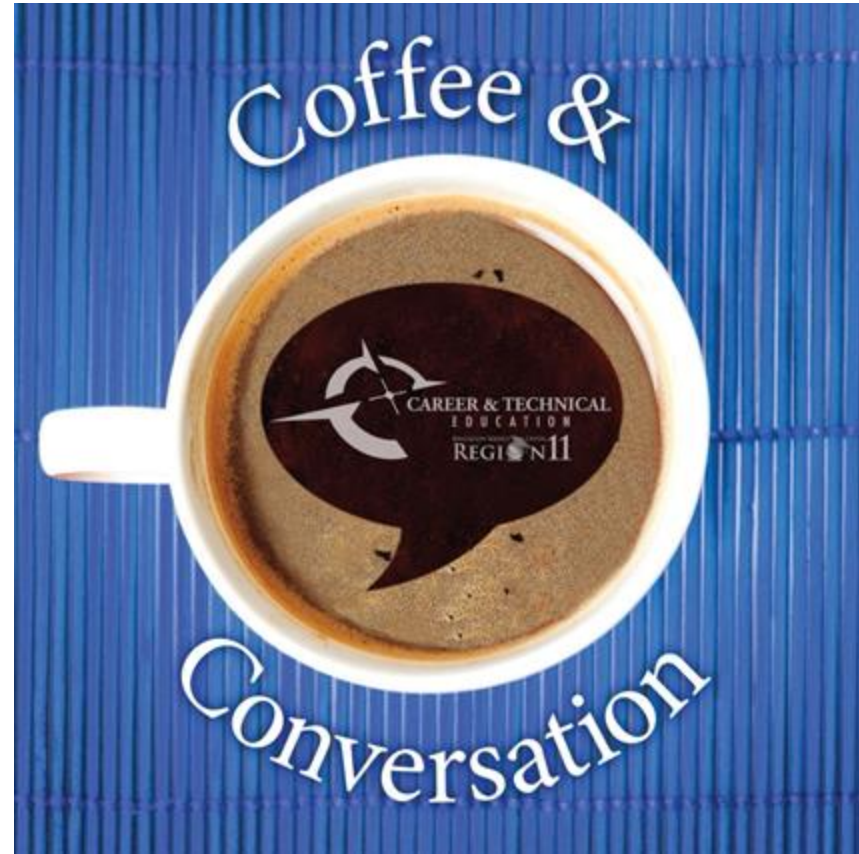
