Running Requisition Status Report

1	Click on “ Reports ” tab	
2	Click on “ Requisition Status Report ”	
3	Type NSLP into the “ Program ” field	
4	Type date ranges in “ Req. Delivery Date ” *If current school year is 2023-2024, enter 07/01/23 to 06/30/24 as date range.	
5	Under “ Search Criteria, ” click “ Execute ”	
6	To Print to PDF: A. “ Click Print to PDF ” open file at bottom of screen	To Export to Excel: B. Click “ Export ” and open file at bottom of screen
