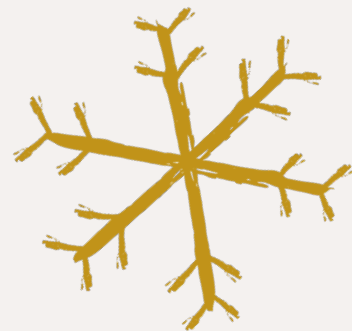
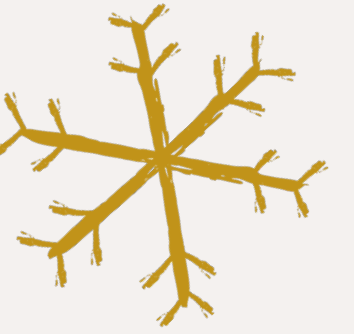
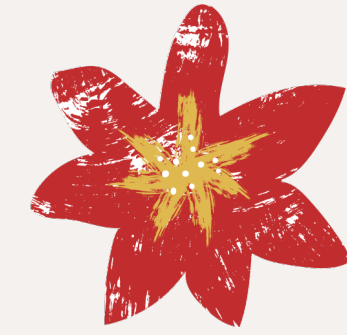

Must Be 0 (Fall PEIMS)

(Fall PEIMS)
- 30305-0025 – StaffSectionAssociation for ECDS BeginDate
and EndDate Must Not Be Blank





Downgraded Business Rules

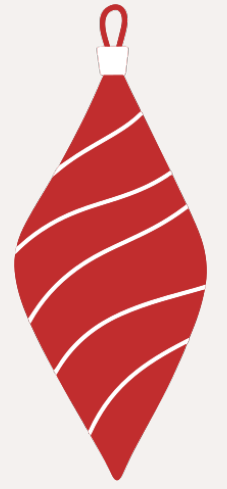


- 30090-0105 – PE Course and Nbr Students Greater Than 0, Nbr Days Taught Week and Nbr Minutes Taught Must Not Be Blank **(Will Be Upgraded for 2025-2026)**
- 40100-0109 – If Grade Lvl Is PK and ADA Is 1, 2, 3, or 6 Then At Least One PK Qualifier Must Be Reported (Analyze Qualification April 1 not Qualified After July 1- Adding to Desk Audit)

RF Tracker

TEA has extended the due date for the LEAs to have RF Tracker data uploaded, promoted, validated, and fatal free to January 17th, 2025.





ECDS

TEA has changed the Section Begin and End Dates to not being required for ECDS. Deactivated 30305-0025.

Lots of issues being reported regarding Homeroom Indicator. Remember it should only be on one section for reporting student data. It should also match the section in which the student was tested.

Verify the assessment date for the student is within their actual enrollment in the district.

Issues with assessments must be referred to the assessment vendor.
